⁵ <u>HLED415</u>: The ACC returned and requested the current syllabus be attached for credit change comparison review.

⁶ <u>A/HI305</u>: The ACC returned due to a lack of clarity on assignments and deadlines in schedule. Commissioners also requested the current syllabus be included for credit comparison.

⁷ DSGN310: The ACC returned with a request for a more thorough description of regular and substantive interaction for the online course.

⁸ ELED365; ELED375; ELED455; ELED466: The ACC returned and requested further syllabus updates.

⁹ <u>SPED350</u>; <u>SPED351</u>; <u>SPED453</u>; <u>SPED454</u>; <u>SPED455</u>; <u>SPED456</u>: The ACC returned and requested further syllabus updates.

¹⁰ <u>ART280</u>: The ACC returned for more clarity in "transition" in weekly schedule for weeks 4 and 5, and a more thorough accounting of regular and substantive interaction.

¹¹ <u>MUS101</u>: The ACC returned with a request for more clarity on regular and substantive interaction in online syllabus.

¹² <u>Human Rights Minor</u>: The ACC approved pending approval of HIST275.

¹³ <u>DISA350</u>: The ACC returned due to 5-credit syllabus and 3-credit syllabus example appearing too similar when it comes to accounting of student work.

¹⁴ ENTR498: The ACC returned with a request for further updates to syllabus, including more examples of what is expected to be done compared to the hours/credits.

¹⁵ <u>LDST416</u>: The ACC returned with a request for more clarification on regular and substantive interaction in online syllabus.

¹⁶ LDST453: The ACC returned with a request for additional rationale on why this course should exist, how it is

different/compared to LDST452, and why repeatability of LDST452 may not be an option.

¹⁷ FAIR304A: The ACC approved this proposal.
