OUTREACH AND CONTINUING EDUCATION COMMITTEE Meeting Minutes of April 17, 2024

SOCEC Chair Jennifer Seltz called the meeting to order at 4:01, welcoming 11 attendees (roster attached).

The meeting minutes of <u>March 20, 2024</u> and <u>proposed by-law revisions</u> were electronically approved as written on April 12, 2024.

Reports and Announcements

Discussion Item

Non-Credit Certificate Program Partnerships

Robert Squires, Vice Provost for Outreach and Continuing Education Committee, gave a <u>presentation on Professional and Continuing Education (PCE) third-party programs</u> as a follow-up to concerns raised during the April 8, 2024 Faculty Senate meeting.

The presentation focused on the context, initiation, and monitoring of third-party programs and also described PCE-developed programs. Committee members raised questions and discussed issues related to enrollment, demand, and marketing, as well as faculty and department involvement in curriculum development and review and program implementation.

The Vice Provost reported that there is revenue sharing with colleges for programs developed with faculty. The goal is to enroll 500 students through continued Professional and Continuing Education program development over the next five years. Current WWU net revenue for third-party programs is approximately \$14,000 for this year.

In response to a question about whether third-party providers share data regarding what courses might be successful, the Vice Provost reported that the providers review data regularly and that the PCE Director is in monthly communication with the providers.

Chair Seltz wrapped up the discussion by stressing the importance of remembering the audience that OCE is communicating with (e.g. alumni, faculty) about WWU's third-party partnerships.
